4.	Chairman AnL provide a summary of activities throughout the last year. The Annual Report was published in January 2022 and can be accessed on the web site <a href="here">here</a> .  The 2021 season was affected by the Covid 19 pandemic restrictions early in the year. The catch was higher than 2020 but overall, the trend is still one of declining catches and salmon stocks.  A full electrofishing survey of the river was carried out along with additional survey sites as part of the National Electrofishing Programme for Scotland (NEPS). Data is still being analysed but initial impressions are that the juvenile salmon are well distributed and numbers within the river are encouraging.  Anthony also thanked Valerie Wardlaw who had been administrator for the Board and Trust for her hard work over the last nine years. Valerie had decided to step down from the role to pursue personal interests and Clare

	An electrofishing survey of the mainstem will be carried out this summer and combined with analysis of historical data from the previous surveys.	
	Adult salmon scale sample programme is underway on the lower Findhorn as part of a Scotland wide Government programme.	
	Work continues on poaching and predator control and a wide range of river works issues and developments. The Board and Trust are promoting riparian woodland restoration to ameliorate the effects of climate change and a presentation will follow the AGM.

	Revaluation of Findhorn Rateable Value The Board have agreed to a revaluation of the Findhorn by Moray and Highland Councils. AnL to contact Councils.	AnL
	Christopher Longstaff raise two concerns by letter regarding the fish disease outbreak earlier this season and whether there was a case for reopening a hatchery on the Findhorn.	
	RL indicated that he had recently received a report on the diseased salmon sampled by the Fish Health Inspectors and had distributed the results to the Board. In summary Saprolignia, a fungal infection, was the most likely cause of the loss of salmon however, a range of other pathogens had also been noted. RL was seeking some further clarification of the results with the Inspectors.	RL
	RL indicated that the hatchery operation had been closed down for around six years. Although some limited data from the programme showed a small improvement in juveniles after stocking, information from studies elsewhere increasingly indicated that hatcheries provided little benefit to rivers with a good run of wild fish, it was generally considered a better option to allow the fish to spawn naturally. In a situation where a man-made problem had affected salmon access and stocks such as a hydro dam then there was a clear case for establishing a hatchery programme for mitigation. Fisheries Management Scotland has recently commissioned a range of online films as batchery exerctions and RL would circulate the links ofter the meeting.
